WHEREAS, the City of Bloomington Township is a participant in the Illinois Municipal Retirement Fund; and

WHEREAS, it is necessary for the Township to designate a new person to serve as the Township's authorized agent when dealing with IMRF.

NOW, THEREFORE, BE IT RESOLVED by the Township Board of the City of Bloomington Township, McLean County, Illinois:



Pursuant to Section 7 - 135 of the Illinois Pension Code, Deborah L Skillrud is authorized, on behalf of the Township, to file a Petition for Nominations of an Executive Trustee of IMRF and to cast a Ballot for Election of an Executive Trustee of IMRF.

This Resolution shall be effective May 1, 2013.



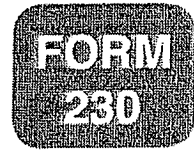


