**MINUTES OF THE TOWN OF THE CITY  
OF BLOOMINGTON TOWNSHIP  
MONDAY, OCTOBER 26, 2015**

The Board of Trustees for the Town of the City of Bloomington Township met in the Council Chambers of the City Hall Building at 6:30 p.m. on October 26, 2015.

The meeting was called to order by Trustee Renner and the following were present:

Trustees: Kevin Lower, David Sage, Mboka Mwilambwe, Karen Schmidt, Scott Black, Diana Hauman, Amelia Buragas, Jim Fruin, Joni Painter and Tari Renner.

Staff present: Cherry L. Lawson Township Clerk; Steve Scudder, Township Assessor and Deborah Skillrud, Township Supervisor.

Approval of the Minutes of September 28, 2015 Board Meeting, as submitted by Cherry Lawson, Town Clerk.

Motion by Trustee Schmidt, seconded by Trustee Painter that the Minutes of September 28, 2015 meeting be approved as presented.

Motion carried, (viva voce).

Action and Approval of the Board on Monthly General Town Fund, General Assistance Fund and Evergreen Memorial Cemetery Audits of September 2015 accounts.

Motion by Trustee Schmidt, seconded by Trustee Painter that the General Town Fund, General Assistance Fund, and Evergreen Memorial Cemetery Audits for the month of September 2015 be approved as presented.

Ayes: Trustees Lower, Sage, Mwilambwe, Schmidt, Black, Hauman, Buragas, Fruin, Painter and Renner.

Nays: None.

Motion carried.

Approval of the General Town Fund anticipated expenditures as presented and certified.

Motion by Trustee Schmidt, seconded by Trustee Painter that the General Town Fund anticipated expenditures be approved as presented.

Ayes: Trustees Lower, Sage, Mwilambwe, Schmidt, Black, Hauman, Buragas, Fruin, Painter and Renner.

Nays: None.

Motion carried.

Proposed Tax Levy for tax year 2015 to be used in Fiscal Year 2017, (April 1, 2016 to March 31, 2017).

Motion by Trustee Schmidt, seconded by Trustee Black to recommend that the estimated Tax Levy for Tax Year 2017 in the amount of \$2,251,600 be approved.

Ayes: Trustees Sage, Mwilambwe, Buragas, Fruin, Renner, Schmidt, Black, Hauman, Painter, and Lower.

Nays:

Motion carried.

Deborah Skillrud, Township Supervisor, addressed the Board. She spoke about the workfare. Second Presbyterian Church and Home Sweet Home Ministries/Mission Mart have hired a number of General Assistance (GA) clients for wage earning jobs.

Trustee Schmidt noted that Heartland Community College's (HCC) Skills for Success class was cancelled due to budgetary reasons. It seemed to be a successful program. Ms. Skillrud responded there was nothing to do at this moment. She welcomed ideas to assist GA clients in the employment process.

Currently the focus was on light duty opportunities. There were GA clients who were unable to be placed at various job sites for a variety of reasons. Bloomington Daycare Center had just become a sponsor site for light duty. Next week some prescreened light duty GA clients will be assigned to the Daycare Center to perform housekeeping chores. Township staff hoped to develop mailing opportunities, (i.e. stuffing envelopes, etc.), for light duty assignment as well.

Additional educational opportunities included the Bloomington Public Library's computer class. Township staff had also communicated with Goodwill and Home Sweet Home Ministries. She noted the importance of email correspondence for GA clients. Finally, she hoped that state funding would be restored which would allow HCC to refocus on adult education.

Pilot program workshops have been held at the Township building the last couple of weeks. The former Skills for Success instructor led the workshops. She hoped the workshops would be successful.

Ms. Skillrud also invited the Board to tour the Township building and/or Evergreen Memorial Cemetery at any time.

Steve Scudder, Township, Assessor, addressed the Board. He cited the updated ward graphs: 1.) number of parcels; 2.) total assessed value; 3.) single family homes assessed value; 4.) commercial assessed value; 5.) amount of change and 6.) ward map with total assessed value and number of parcels. Based upon the number of parcels, the City was divided equally. There were similar sized parcels in each ward. The total assessed value had increased slightly. He noted values differed by ward. The wards did not vary on single family homes assessed value. By contrast, the commercial assessed value by ward did vary. There had not been change within wards when comparing previous appraised value and current appraised value.

Trustee Fruin questioned the future assessed values and growth with the Mitsubishi Plant closure. Mr. Scudder believed there had not been much growth or much decline. Trustee Fruin stated the market had been good the past few years. He hoped growth would continue. Mr. Scudder noted Hy-Vee had helped on the commercial side.

Trustee Renner opened the meeting to Public Comment. No one came forward to address the Board.

Motion by Trustee Schmidt, seconded by Trustee Black to adjourn. Time: 6:42 p.m.
