ELECTED OFFICIAL & COMMITTEE REPORTS

PLANNING COMMISSION – There was no meeting, nor report at this time.

ASSESSOR – Assessor Von Bergen congratulated Shannon Combs on winning the election of Township Assessor, welcomed her and are working on the transition.

HIGHWAY COMMISSIONER – Commissioner Nickels reported patching, garbage, signs, Nichol Rd pavement & culverts positive drainage, working on grant for Hebron Rd & met with the engineer.

TRUSTEES – Trustee Von Bergen was working on the trees and noticed the property marker post is knocked over. It has been remarked twice which allows farm fields to encroach. Clerk Elswick will check with the Boy Scouts to see if they can help survey or re-locate the property pins.

CEMETERY – 1 staking, 1 grave sale.

SUPERVISOR: GREEN STREET – Received \$3000 for remainder of August, all of September, all of October, & \$300 to November. The proper amortization schedule was sent. GENERAL ASSISTANCE – 0 inquiries. ADMIN/BUILDING – The Hebron Area Business Association will start using the building. The Township mortgage refinance is complete. The Food Pantry is inquiring about getting a grant for a generator to supply the freezers. One elector sent letter of interest for the Trustee position opening in May.

CLERK – Reported Oath of Office can be given after receipt of the Certificate of Election and will schedule with each individual.

OLD BUSINESS – There was no old business discussed at this time.

NEW BUSINESS – Trustee Werra motion to hold Budget Workshop April 20, 2021 at 7pm. Second Trustee Von Bergen. Roll call vote Ayes – 5: Trustee Schaid, Trustee Werra, Trustee Reed, Trustee Von Bergen, Supervisor Lech. Nays – 0. Motion passed. Trustee Von Bergen motion to retain Evoy, Kamschulte, Jacobs & Company to prepare the Annual Financial Report/Statements.
