

TAX LEVY ORDINANCE
TOWNSHIP
ORDINANCE NO. _____

An ordinance levying taxes for all town purposes for Stookey Township, St. Clair County, Illinois, for the tax year 2018, collectable in 2019.

BE IT ORDAINED by the Board of Trustees of Stookey Township, St. Clair County, Illinois, as follows:

SECTION 1: That the sum of FOUR HUNDRED SEVENTY FIVE THOUSAND FIVE HUNDRED THIRTY ONE DOLLARS (\$475,531.00) is hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defrayal the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purpose as:

Police Protection Fund

General Town Fund

FICA (Social Security)

Park Maintenance

For the year 2019.

SECTION 2: That the amount levied for each object and purpose shall be as follows:
