

**TAX LEVY ORDINANCE
ERIENNA TOWNSHIP ROAD DISTRICT**

**AN ORDINANCE LEVYING TAXES FOR ALL ROAD PURPOSES
FO ERIENNA TOWNSHIP, GRUNDY COUNTY, ILLINOIS,
FOR THE TAX YEAR 2021, COLLECTABLE IN 2022**

BE IT ORDAINED BY THE TRUSTEES OF ERIENNA TOWNSHIP:

SECTION 1: The Highway Commissioner of Erienna Township Road District does hereby determine and declare that the sum of One Hundred Eighty-Seven Thousand, Three Hundred Sixty-Five Dollars (\$187,365.00) is hereby levied upon all property subject to taxation within the Road District as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Road District as required by statute or voted by the people in accordance with the law, for such purposes as:

1. ROAD & BRIDGE
2. INSURANCE
3. PERMANENT ROAD (permanent levy on file with County Clerk)
4. SPECIAL BRIDGE

for the year 2021.

SECTION 5: If any section, subdivision, or sentence of this ordinance shall for any reason be held invalid or to be unconstitutional, such finding shall not affect the validity of the remaining portion of this ordinance.

SECTION 6: This ordinance shall be in full force and effect after its adoption, as provided by law.

Amount to be levied was determined by the Highway Commissioner of the Erienna Township Road District.
