NOVEMBER 24, 2014

The Board of Trustees for the Town of the City of Bloomington Township met in the Council Chambers of City Hall Building at 6:31 P.M. on November 24, 2014.

The meeting was called to order by Trustee Renner and the following were present:

Trustees: Scott Black, Karen Schmidt, Kevin Lower, Jim Fruin, Judy Stearns, David Sage, Diana Hauman, Joni Painter, Mboka Mwilambwe and Tari Renner.

Also present were Staff: Tracey Covert, Town Clerk, Steve Scudder, Township Assessor and Deborah Skillrud, Township Supervisor.

The Minutes of October 27, 2014 Regular Session were presented.

Motion by Trustee Painter, seconded by Trustee Black that the reading of the Minutes October 27, 2014 Regular Session meeting be dispensed with and approved as presented.

Motion carried, (viva voce). Trustee Mwilambwe abstained.

The audit for the Evergreen Memorial Cemetery, General Town Fund and the General Assistance Fund and Exhibit A. Request for Payment were presented for October 2014.

Motion by Trustee Schmidt, seconded by Trustee Black, to approve the audits as presented and placed on file.

Ayes: Trustees Black, Schmidt, Lower, Fruin, Stearns, Sage, Hauman, Painter, Mwilambwe and Renner.

Nays: None.

Motion carried.

The anticipated expenditures were presented.

Motion by Trustee Schmidt, seconded by Trustee Painter, to approve the anticipated expenditures.

Trustee Renner introduced the Tax Levy Ordinance for Tax Year 2014 to be used in Fiscal Year 2016, (April 1, 2015 – March 31, 2016).

Motion by Trustee Schmidt, seconded by Trustee Painter to adopt the estimated 2014 Property Tax Levy in the amount of \$2,251,600.

Ayes: Trustees Black, Schmidt, Lower, Fruin, Stearns, Sage, Hauman, Painter, Mwilambwe and Renner.

Nays: None.

Motion carried.

This list of meetings for calendar year 2015 for the City of Bloomington Township and Evergreen Memorial Cemetery were presented.

Motion by Trustee Schmidt, seconded by Trustee Hauman to approved the list of meetings for calendar year 2015.

Motion carried, (viva voce).

Deb Skillrud, Township Supervisor, addressed the Board. She had prepared a written report. She informed the Board that the Evergreen Memorial Cemetery employees were integrated into the Township's employee health insurance plan. This is the same plan as the City of Bloomington.

Trustee Fruin questioned the Board signing the monthly audits. He questioned if the process could be streamlined. Ms. Skillrud noted the addition of the Cemetery's monthly audit report. The Township offices were in different locations. She planned to research same.

Steve Scudder, Township Assessor, addressed the Board. He had prepared a written report. The Board of Review process should be completed by December 2014. Work had started on the 2015 assessment cycle. His office would be creating a commercial assessment model that would bring consistency. Variables would be selected with the goal of achieving better outcomes. Mike Ireland would be providing assistance in the spring 2015. This would be a quadrennial year. He noted Mr. Ireland's experience and knowledge. He had assisted with training the new staff members.

Trustee Renner opened the meeting to Public Comment. No one came forward to address the Board.

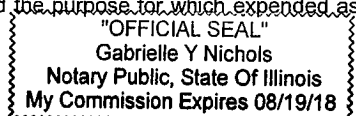
