TAX LEVY ORDINANCE

TOWNSHIP

ORDINANCE No. 2020A

An ordinance levying taxes for all town purposes for Bruce Township,
LaSalle County, Illinois, for the tax year 2019, collectable in 2020.

BE IT ORDAINED by the Board of Trustees of Bruce Township,
LaSalle County, Illinois, as follows:

SECTION 1: That the sum of FOUR HUNDRED ONE THOUSAND THREE HUNDRED DOLLARS (\$401,300) are hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as:

AUDIT FUND, GENERAL ASSISTANCE FUND,

INSURANCE FUND, IMRF PENSION FUND,

for the year 2019.
