FOR ERIENNA TOWNSHIP,
GRUNDY COUNTY, ILLINOIS
FOR THE TAX YEAR 2021
COLLECTABLE IN 2022**

BE IT ORDAINED BY THE SUPERVISOR AND TRUSTEES OF ERIENNA TOWNSHIP:

SECTION 1: The sum of Ninety-One Thousand, Three Hundred Nineteen Dollars (\$91,219.00) is hereby levied upon all property subject to taxation within the township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as:

1. GENERAL TOWNS FUND

2. GENERAL ASSISTANCE FUND

For the 2021 year collectible in 2022.
