THE BOARD OF TRUSTEES met at the Robinson Township Office at 5:30 p.m. June 18, 2015. Persons from the public attending the meeting were as follows: Stan Mullins, Becky Taylor, Janie Thackrey, Lacey Whipkey, and Matthew Wilson.

The following official business was transacted. The meeting was called to order by Chairman Larry McCoy. Clerk Vickie Gribben then called the roll.

Mr. McCoy then requested a motion to start the Town Budget Hearing for fiscal year 2015-2016. Larry McCoy made the motion to start the Town Budget Hearing. Pat Richards seconded. Motion carried with vote as follows: Larry McCoy-yes; Pat Richards-yes; Lori Hodge-yes.

Chairman McCoy told the trustees that one change had been made to the budget which was to line item 830 Capital Outlay—Equipment. The change was from \$2500 to \$3000 because the cost of the computers ran higher than estimated partly due to the purchase of a network storage unit which has a dual backup and also eliminates the necessity of linking to one main computer. Total Budget for the fiscal year beginning April 1, 2015 and ending March 31, 2016 is for \$675,685 which is a \$108,256 decrease from last year's budget.

Mr. McCoy asked if there were any questions. There were none. Pat Richards made the motion to adopt the Town Budget for fiscal year 2015-2016. Lori Hodge seconded. Motion carried with vote as follows: Pat Richards-yes; Lori Hodge-yes; Larry McCoy-yes.

Mr. McCoy said to let the record show that Shirley Berry came to the Township Office at 5:39 p.m. Chairman McCoy asked Mrs. Berry if she had looked through the Town Budget and did she want to vote to adopt it. Mrs. Berry said yes.

Mr. McCoy requested a motion to close the Town Budget Hearing. Lori Hodge made the motion and Shirley Berry seconded. Motion carried with vote as follows: Lori Hodge-yes; Pat Richards-yes; Larry McCoy-yes; Shirley Berry-yes.

Meeting adjourned at 5:45 p.m.
