

TAX LEVY ORDINANCE
ROAD DISTRICT
ORDINANCE NO. ___

An ordinance levying taxes for all road purposes for Stookey Road District, St. Clair County, Illinois, for the tax year 2018, collectable in 2019.

BE IT ORDAINED by the Board of Trustees of Stookey Township, St. Clair County, Illinois, as follows:

SECTION 1: That the Highway Commissioner of Stookey Road District on Nov 5th, 2018 does hereby determine and declare that the sum of FIVE HUNDRED EIGHT THOUSAND ONE HUNDRED FORTY EIGHT DOLLARS (\$508,148.00) is hereby levied upon all property subject to taxation within the Road District as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Road District as required by statute or voted by the people in accordance with the law, for such purpose as:

For the year 2019.

SECTION 4: That the Board of Trustees does hereby certify that the amount levied herein is necessary to be raised by taxation for road purposes for Stookey Road District.




SECTION 6: That this ordinance shall be in full force and effect after its adoption, as provided by law.


ADOPTED this 3RD day of December, 2018 pursuant to a roll call vote by the Board of Trustees of Stookey Township, St. Clair County, Illinois.


