Recent "General Administrative Duties of the Highway Commissioner" trainings are also available and an excellent resource. The T2 Center has a new session that meets the requirement of public agencies relating to "Sexual Harassment Prevention" training that must be completed annually.

Illinois Department of Human Rights – Sexual Harassment Prevention Training

Effective January 1, 2020, the Workplace Transparency Act (Act) charged the Illinois Department of Human Rights to develop a model Sexual Harassment Prevention training program for Illinois employers. The Act requires all Illinois employers, including local governments, to train employees on sexual harassment prevention. This online training meets the requirements of the Act and should be completed by all employees annually.
