Two (2) tables presented provided a breakdown of change from 2014 to 2015. Table 1 addressed valuation completed at the Township level for the County. He cited the following findings regarding increases: Residential Revaluation had the largest increase; New Residential Construction was second; and New Commercial Construction was third. Table 2 provided a breakdown of the numbers separated by change and use codes.

Subject: Assessor Report

This is the time of the year we are going to the Board of Review to make corrections to assessments that were submitted to the county in the fall. Once we turn the values over to the county the assessment notices are sent to the property owners with the value that we put on the property for January 1 of the year. (In this case 2015) There is a 30 day time frame for a property owner to review their assessed value and to agree or disagree with that value. If they agree with the value we apply they may also look at the value that is on their neighbor's property to see if they are being treated the same. If they feel the value is incorrect or that they are being treated differently than others in the neighborhood they would file a complaint form. This form is often called an appeal form, to protest their assessed value.

We made changes to about 12,000 assessments for 2015 and we received a multiplier of 1 from the county. The following charts display the number of Appeals that we had for the last five years and the change in the assessed value that was the outcome of the hearings. The main classes of property are commercial and single family homes they receive the highest amount of appeals. Keep in mind 2015 is a Quadrennial year the last one was in 2011.

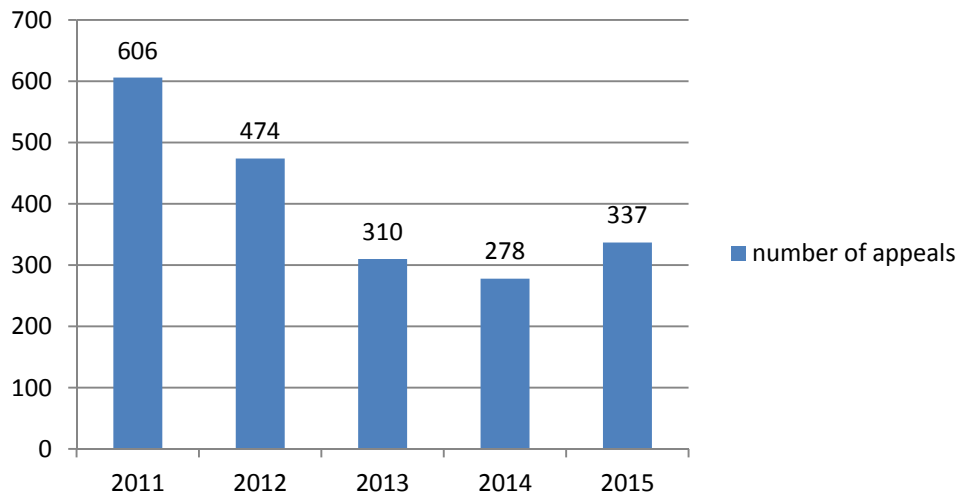
Chart 4 – Dollar amount change of commercial appeals year over year

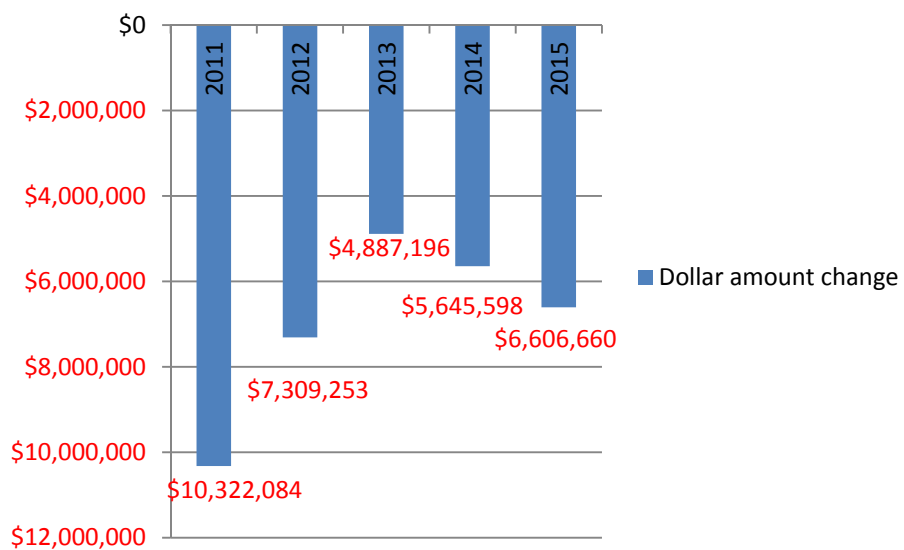
Chart 6 – Dollar amount change of Single family homes year over year

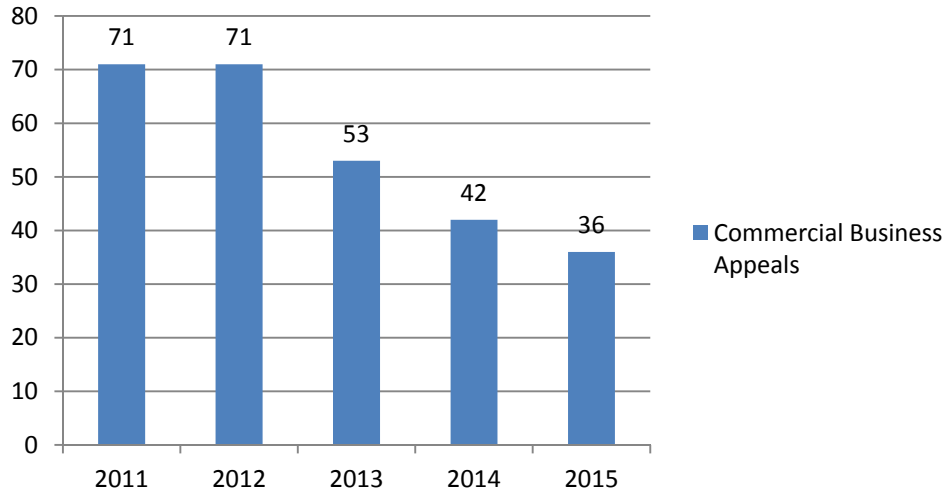
