MINUTES OF THE TOWN OF THE
CITY OF BLOOMINGTON TOWNSHIP
MONDAY, AUGUST 23, 2021; 5:30 P.M.

The Board of Trustees for the Town of the City of Bloomington convened in regular session in the Government Center Chambers at 5:30 p.m., Monday, August 23, 2021. The meeting was called to order by Trustee Mwilambwe.

Trustee Mwilambwe directed the Township Clerk to call the roll and the following members of the Board answered present:

Trustees present: Jamie Mathy, Donna Boelen, Sheila Montney, Julie Emig, Nick Becker, Jennifer Carrillo, Mollie Ward, Jeff Crabill, Tom Crumpler, and Mboka Mwilambwe.

Elected officials present: Deborah L. Skillrud, Supervisor, and Steve Scudder, Assessor.

Staff present: Leslie Yocum, Township Clerk.

Trustee Mwilambwe explained the Board would use an electronic voting system for the meeting and asked the Township Clerk to provide additional details. Leslie Yocum, Township Clerk, explained the program to the Board Members. The vote results would be displayed on the monitors.

Action and Approval of Minutes of the August 2, 2021, Board Meeting, as presented.

Presentation and Action on the Audit Report for Fiscal Year April 1, 2020, to March 31, 2021, by Richard W. Phillips, CPA.

Deborah Skillrud, Supervisor, stated that Mr. Phillips was unable to attend the meeting due to illness. He had reported there were no internal control issues.

Trustee Mwilambwe confirmed the motion would include placing the report on file. Mrs. Skillrud responded affirmatively.

Motion by Trustee Boelen, seconded by Trustee Montney, the Audit Report for Fiscal Year April 1, 2020, to March 31, 2021, be accepted and placed on file.

Trustee Mwilambwe directed the Township Clerk to call the roll which resulted in the following:

Presentation and Action on the Bid for Parking Lot and Curb Ramps.

Motion by Trustee Boelen, seconded by Trustee Crumpler, that the bid be awarded to Stark Excavating, in the amount of \$181,584, and the Supervisor be authorized to execute the necessary documents.

Presentation and Action on the Execution of a Shared Space Agreement Between the City of Bloomington Township and Tazwood Community Services, Incorporated, for Office Space at the Township Center Building.

Motion by Trustee Emig, seconded by Trustee Becker, that the agreement be approved.

Trustee Mwilambwe directed the Township Clerk to call the roll which resulted in the following:

Deborah Skillrud, Supervisor, addressed the Board. Her report was in the meeting packet. She thanked the Board for their support of the shared space agreement with Tazwood Community Services. It would benefit both entities. She highlighted the POTS, (Promoting Others to Succeed), Program. The Township had received \$1,830.76 from East Jordan for twenty-two (22) skids/pallets of recycled pots and trays. She had received telephone calls from other local governments inquiring about the program.

Trustee Mathy questioned if Township experienced an increase in applicants after the recent flooding. Mrs. Skillrud responded affirmatively. The Township had received an increase number of service requests. None of the requests were out of the ordinary.

Trustee Crabill requested Mrs. Skillrud to comments on the Township Fund balances discussed at the last meeting. Mrs. believed the emailed memorandum to the Board provided clarification needed and no further comments were necessary.

Steve Scudder, Township Assessor, addressed the Board. Per statute January 1, 2021 was the assessment date. Staff used a three (3) year sales average to determine assessments. Adjustments were made based upon sale prices, (i.e. higher prices meant an increased assessment, and lower prices meant a decreased assessment). Staff continued to work through valuations of the City.

Trustee Mwilambwe opened the meeting to receive Public Comment. Leslie Yocum, Township Clerk, stated that no one had registered to speak live or had submitted emailed public comment.

Motion by Trustee Boelen, seconded by Trustee Becker, that the meeting be adjourned.

Trustee Mwilambwe directed the Township Clerk to call the roll which resulted in the following:

Workfare Programs: The Wellness Lifestyle Classes were held in person at the Bloomington Public Library on August 6, 14, 20, and 27, 2021. Seven (7) active General Assistance (GA) clients were in attendance. Topics discussed include dietary supplementation, interpreting lab work, and healthy lifestyle choices. The Wellness Lifestyle Class plans to continue in person at the Library's Community Room every Friday at 11:00 a.m.

Skills to Succeed currently lacks participants. The class is on hold. Two (2) participants attended the class on August 2, 2021. The instructor was unavailable for class on August 9, 16 and 23, 2021.

POTS Recycling: The POTS program continues to operate smoothly. Additional floor space has improved the traffic flow around the tables.

POTS pick up has moved from weekly to every other week. Township continues to rent a three person, 15' truck to handle the volume. Load level will continue to be monitored. If demand continues, Township will pick up through the month of October.

General Assistance (GA): Total August cases for GA are listed on attached System Activity Report.

Eighty-two, (82), individuals submitted applications, which was twenty-one (21) more than July. Forty-three, (43), are *potentially eligible* for GA and thirty, (30), are *potentially eligible* for Emergency Assistance, (EA).

There was a church case, (McLean County resident), and a Yates Township resident requested intake.

Three, (3), GA clients gained a full time employment with: District 87, Dollar Tree, and Express Employment Professionals.

One (1) client continues to be employed part-time in a work program through Heartland Community College, and one, (1), continues to be employed full time at Youth Build. Five, (5), clients continue working part-time with National Able.

The Township did not receive Supplemental Security Income recovery funds from the State of Illinois in August.

COVID - 19 Update: The Governor announced a statewide indoors mask mandates for all residents regardless of vaccination status effective Monday, August 30th.

Residential Eviction Moratorium Governor Pritzker has issued Executive Order 2021 - 19. It extended Executive Order 2021 - 13 Residential Eviction Moratorium through September 18, 2021. It has been amended: see Section 9. Nothing in this Order shall preclude a person or entity with a legal right to pursue an eviction or possessory action from challenging the

truthfulness of a tenant's, lessee's, sub-lessee's, or resident's Declaration in court, as permitted by law & the applicable Court's rules.

Illinois Department of Employment Security Pandemic Unemployment Insurance (PUI) and other federal unemployment programs expired on September 4, 2021. PUI applications are being accepted until October 6, 2021. However, PUI benefits are only payable retroactively through the week ending September 4th, 2021.

FEMA/CURES Grant: No updates. This remains under review with the state.

Parking Lot Improvements: Notice of Award was announced to Stark Excavating, Inc. Contract price of the awarded Contract is: \$181,584. Notice of Award, Notice to Proceed and Agreement Between Owner and Contractor for Construction Contract were signed on September 1, 2021.

Evergreen Memorial Cemetery (EMC): The Cemetery Walk will take place on September 25 & 26 and October 2 & 3, 2021. Ticket sales begin on August 31st. The Cemetery Walk is soliciting businesses to advertise in the playbill and for event sponsors. 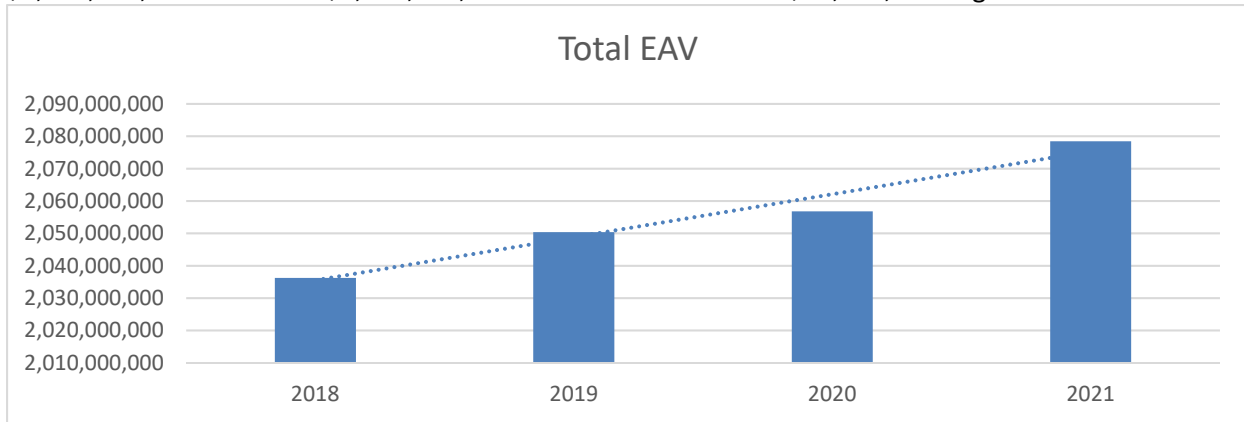

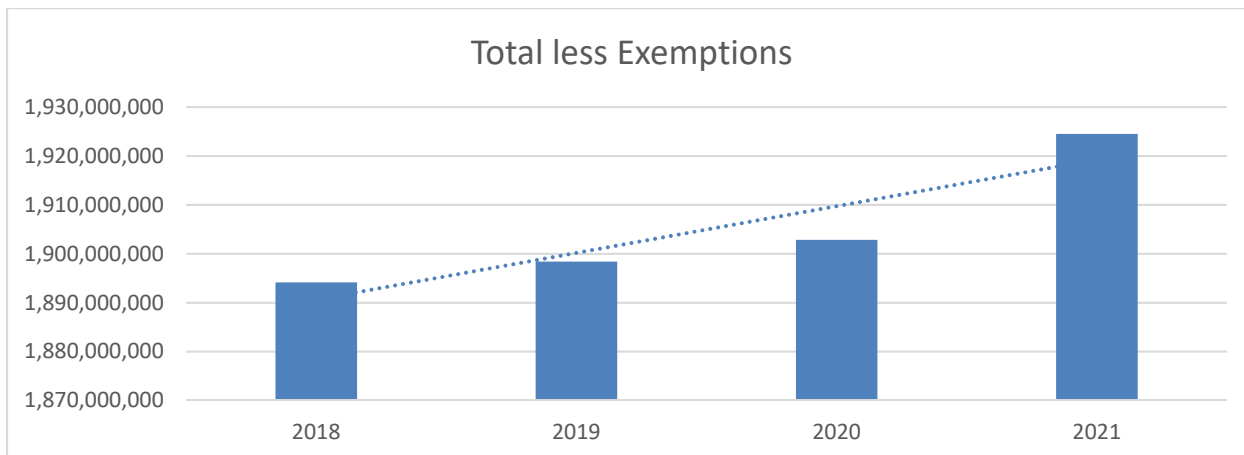

The amount of exemptions that are granted affects the amount of gross taxable value. In 2020 we saw a big increase in the exemptions, mainly in the disabled Veterans amounts. This does not mean that a taxing body will not receive what was requested, unless the rate is capped and maxed out. What it does mean is that the burden is shifted to other tax payers.

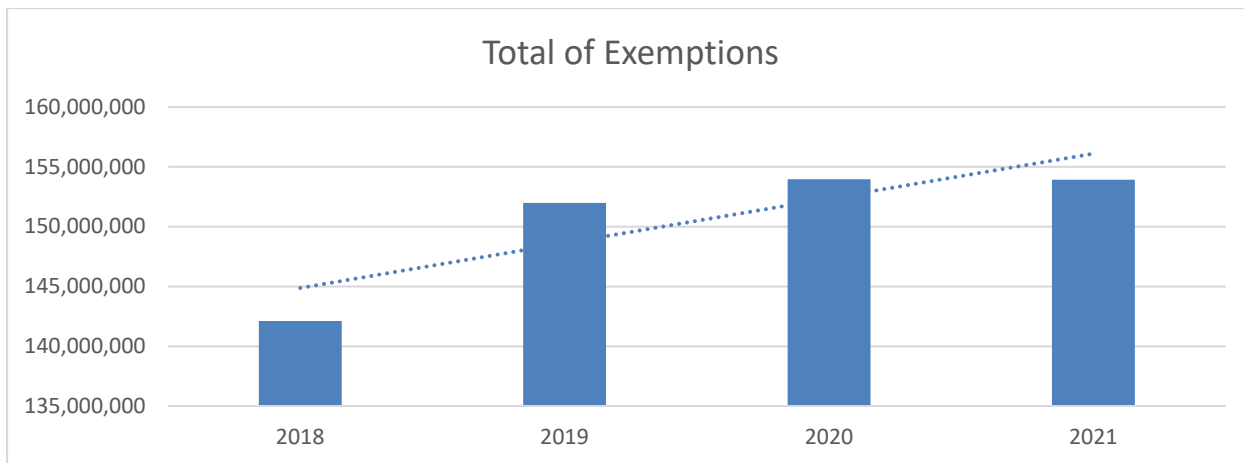
Graph 1 is the total EAV (Equalized Assessed Value). We see the growth from 2018 to 2021 from \$2,036,249,146 in 2018 to \$2,078,418,043 in 2021. That is about \$40,000,000 in growth.



Graph 2 is the total of Exemptions. In 2018 was \$142,103,628 then in 2021 to \$153,918,088. That is about a \$12,000,000 increase of exemptions granted.



Graph 3 is Total of Exemptions. In 2018 the total taxable dropped to \$1,894,145,518 then in 2021 drops to \$1,924,499,955 after the exemptions are subtracted.
