Road and Bridge reports summer work all planned out. Spray patching to begin next week. Tar & Chip (and striping) begins when County is ready. Jimax will be spraying soon (weed control). German-Bliss still working on getting his new tractor in.

Assessor reports that he has taken probably 65 calls since tax bills went out. Assessed values went up 3% across the board for Fondulac Township. County has had some issues with data entry.
