**TAX LEVY ORDINANCE**

**ROAD DISTRICT**

**ORDINANCE NO. 2020B**

An ordinance levying taxes for all road purposes for Bruce Township Road District LaSalle County, Illinois, for the tax year 2019, collectable in 2020.

Be it ordained by the Board of Trustees of Bruce Township, LaSalle County, Illinois, as follows:

SECTION 1: That the Highway Commissioner of Bruce Township Road District on November 4<sup>th</sup>, 2019 does hereby determine and declare that the sum of TWO HUNDRED NINETY-NINE THOUSAND NINE HUNDRED DOLLARS (\$299,900) are hereby levied upon all property subject to taxation within the Road District as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Road District as required by statute or voted by the people in accordance with the law, for such purposes as:
