General Assistance Fund Bills – Trustee Von Bergen motion to approve General Assistance Fund expenditures in the amount of \$82.69. Second Trustee Mayerck. Roll call votes Ayes – 4: Trustee Mayerck, Trustee Von Bergen, Trustee Reed & Supervisor Lech. Absent – Trustee Werra Nays – 0. Motion passed. Cemetery Fund Bills – Trustee Reed motion to approve Cemetery Fund expenditures in the amount of \$1,450.00. Second Trustee Mayerck. Roll call votes Ayes – 4: Trustee Mayerck, Trustee Von Bergen, Trustee Reed & Supervisor Lech. Absent – Trustee Werra Nays – 0. Motion passed. Road District Bills – Trustee Von Bergen motion to approve Road District Building & Equipment expenditures in the amount of \$0.00, Hard Road Fund expenditures in the amount of \$4,703.23 and Road & Bridge Fund expenditures in the amount of \$26,944.42. Second Trustee Mayerck. Roll call votes Ayes – 4: Trustee Mayerck, Trustee Von Bergen, Trustee Reed & Supervisor Lech. Absent – Trustee Werra Nays – 0. Motion passed.

## ELECTED OFFICIAL & COMMITTEE REPORTS

PLANNING COMMISSION – There was no meeting & no report at this time.

ASSESSOR – Assessor Combs advised the assessments would publish Nov 17<sup>th</sup>, received a high factor of 11%, continued site visits & the county helped with some commercial adjustments.

HIGHWAY COMMISSIONER – Commissioner Nickels reported patching, signs, brush, truck #5 is back & ready, garbage & helped Greenwood Township with paving on Hillside & the cemetery. Salt of \$6193 for 600 ton. County wants to change the way they pay out on bridge repairs/replacement. Looking for help plowing Class B or higher CDL needed.

TRUSTEES – There were no trustee reports at this time.

CLERK – Supervisors Statement was field with the county & published, new printer arrived.

CEMETERY – 3 staking, 0 grave sales, Thanked Karen Lalor & Johnny Eskridge for helping with the flags and garbage before Veterans Day.

SUPERVISOR: GREEN STREET – Still not closed on the property. GENERAL ASSISTANCE – 0 applications & 1 inquiry. Effective 10/01/21 the amount of the General Assistance monthly program went from a maximum of \$319 to \$322.

ADMIN/BUILDING – 2 blinds left to order & install. Changed batteries in smoke detectors & purchased new surge protectors.

NEW BUSINESS – New tax levy will need to post 20 days before vote taken.

OLD BUSINESS – There was no old business discussed at this time.

PUBLIC COMMENTS – There was no public comments at this time.

ADJOURNMENT – The meeting adjourned at 7:26pm.
