Roll call vote Ayes – 4: Trustee Von Bergen, Trustee Werra, Trustee Mayerck & Supervisor Lech. Nays – 0. Absent - Trustee Reed. Motion passed. Road District Bills – Trustee Von Bergen motion to approve Road District Building & Equipment expenditures of \$0.00, Hard Road Fund expenditures of \$4878.06 and Road & Bridge Fund expenditures of \$4100.05 with the addition of \$4139.13 payable to Botts. ELECTED OFFICIAL & COMMITTEE REPORTS

PLANNING COMMISSION – There was no meeting & no report at this time.

ASSESSOR – Assessor Combs continues site visits with a lot on Seaman Rd that have little or no info, working with KLM, has IPAI course for continued education, end of the month TOI bootcamp, made t-shirts for field work.

HIGHWAY COMMISSIONER – Commissioner Nickels reported the usual monthly duties along with working with inmate program 3 days clearing brush & picking up garbage.

CEMETERY – 2 staking, 4 grave sales, received reimbursement from Toirma for tree removal. Quarterly meeting was canceled due to no quorum. Sunken grave has been repaired with a prompt response; Fred repaired damage as well. Another wind storm damage, have been trying to go up on a weekly basis to pick up debris and branches. The wind tears up the grave decorations so there is flower material everywhere. Thanks to Zeke for branch disposal.

SUPERVISOR: GREEN STREET – Randy contacted on 08/09/21 for payoff amount, \$56209.17 - \$600 accrued property taxes = \$55609.17 and Randy would be responsible for 2021 property taxes payable in 2022. Contacted Mike Smoran to represent the Township in the closing. GENERAL ASSISTANCE – 0 applications. ADMIN/BUILDING – Mulched around

trees. Met with Brandon Meier to sign final papers for Eagle Scout project submission. Met with Jeff Vohs from SEMB Bank and signed loan papers for Highway 2 loans. Financial Statement is complete & will approve at September Meeting.
