CALL TO ORDER - At the Regular Town Meeting, held in the town of Hebron, County of McHenry, and State of Illinois, at 7:03p.m. on the 14th day of July was called to order by Nancy Lech, Township Supervisor. General Assistance Fund Bills – Trustee Mayerck motion to approve General Assistance Fund expenditures of \$85.99. Second Trustee Reed. Roll call vote Ayes – 4: Trustee Reed, Trustee Von Bergen, Trustee Mayerck & Supervisor Lech. Nays – 0. Absent - Trustee Werra. Motion passed. Cemetery Fund Bills – Trustee Reed motion to approve Cemetery Fund expenditures of \$1092.50. Second Trustee Mayerck. Roll call vote Ayes – 4: Trustee Reed, Trustee Von Bergen, Trustee Mayerck & Supervisor Lech. Nays – 0. Absent - Trustee Werra. Motion passed. Road District Bills – Trustee Von Bergen motion to approve Road District Building & Equipment expenditures of \$0.00, Hard Road Fund expenditures of \$6311.80 and Road & Bridge Fund expenditures of \$12,065.89. Second Trustee Mayerck. Roll call vote Ayes – 4: Trustee Reed, Trustee Von Bergen, Trustee Mayerck & Supervisor Lech. Nays – 0. Absent - Trustee Werra. Motion passed.

ELECTED OFFICIAL & COMMITTEE REPORTS

PLANNING COMMISSION – There was no meeting & no report at this time.

ASSESSOR – Assessor Combs busy getting books ready for the county. Still reviewing permits from the Village, hired 2 parttime, short term field assistants. Website continues to be a goal of the Assessors office & will continue to collect data.

HIGHWAY COMMISSIONER – Commissioner Nickels reported patching, replacing culverts and driveways on Hebron Rd, the grant work is moving forward, ditch work, tree trimming, mowed once, working on equipment, culvert in Giant Oaks & picked up trash, court move to trial on disobeying road work signs, negotiating terms on paving project.

TRUSTEES – There were no trustee reports at this time.

CLERK – Clerk Elswick reported filing the budget & trustee oath.

CEMETERY – 6 staking, 0 grave sale Wind storm damage where a tree fell on some headstones, filed claim with TOIRMA they will pay up to \$2500 debris damage with no deductible. Head stone damage is the owner's responsibility-they should claim on their homeowner's policy. Tom does communicate that when a foundation is installed. 2 quotes on cleanup & work is completed. Grave dug in the spring sunk, Tom to contacted vendor & it is completed. SUPERVISOR:
GREEN STREET – 2 payments received \$1000 balance due \$56819.96 minus any accrued property tax payments.

GENERAL ASSISTANCE – 2 applications picked up. ADMIN/BUILDING – Payroll reports completed. The Audit Committee reviewed books & satisfied. Auditor still working on financials. Met with an inter from US Fish & Wildlife Service at Hackmatack National Wildlife Refuge & he wanted to know how to engage the Latino Community in their programs. There was a discussion on a hallway art project program & rules or criteria that should be met.

OLD BUSINESS – There was no old business discussed at this time.

NEW BUSINESS – There was no new business discussed at this time.

PUBLIC COMMENTS – There were no public comments at this time.
