\$1,000 per year.	
WHEREAS, according to 605 ILCS 5/6-207, the compensation of the highway	
commissioner shall be fixed by the township board at an annual salary of not less than \$3,000 to	Э
be paid in equal monthly installments, or a per diem amount for each day he or she is necessaril	y
employed in the discharge of official duties;	
WHEREAS, according to 35 ILCS 200/2-70, the compensation the township assessor	
and collector shall be set by the township board at the same time the board sets the compensation	n
of its township supervisor.	
NOW, THEREFORE, BE IT ORDAINED BY Board of Trustees of

17, 2021 and ending May 18, 2025 (January 1, 2022 – January 1, 2026 for assessors and
