

TAX LEVY ORDINANCE
PALATINE TOWNSHIP ROAD DISTRICT
ORDINANCE NO. 07-18 RD

AN ORDINANCE levying taxes for all road purposes for Palatine Township Road District in Cook County, Illinois, for the tax year 2018, collectable in 2019.

BE IT ORDAINED by the Board of Trustees of Palatine Township, Cook County, Illinois, as follows:

SECTION 1: That the Highway Commissioner of Palatine Township Road District on November 26th, 2018 does hereby determine and declare that the sum of two million five hundred eighty thousand dollars (\$2,580,000.00) are hereby levied upon all property subject to taxation within the Road District as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Road District as required by statute or voted by the people in accordance with the law, for such purposes as defined in the General Road Fund for fiscal year 2019.

SECTION 2: That the amount levied for each object and purpose shall be as follows:



SECTION 4: That the Board of Trustees does hereby certify that the amount levied herein is necessary to be raised by taxation for road purposes for Palatine Township Road District.

SECTION 5: That if any section, subdivision, or sentence of this ordinance shall for any reason be held invalid or to be unconstitutional, such finding shall not affect the validity of the remaining portion of this ordinance.

SECTION 6: That this ordinance shall be in full force and effect after its adoption, as provided by law.

TRUTH IN TAXATION
CERTIFICATE OF COMPLIANCE FOR ALL COUNTIES
PALATINE TOWNSHIP ROAD DISTRICT

I, the undersigned, hereby certify that I am the presiding officer of, Palatine Township, and as such presiding officer I certify that the levy ordinance, a copy of which is attached, was adopted pursuant to, and in all respects in compliance with the provisions of Section 18-60 through 18-85 of the "Truth in Taxation" law.

- The taxing district published a notice in the newspaper and conducted a hearing meeting the requirements of the Truth in Taxation Law.
- The taxing district's aggregate levy did not exceed a 5% increase over the prior year's extension. Therefore, a notice and a hearing were not necessary.
- The proposed aggregate levy did not exceed a 5% increase over the prior year's extension. Therefore, a hearing was not held. The adopted aggregate tax levy exceeded 5% of the prior year's extension and a notice was published within 15 days of its adoption in accordance with the Truth in Taxation Law.
- The adopted levy exceeded the amount stated in the published notice. A second notice was published within 15 days of the adoption in accordance with the Truth in Taxation Law.
