Minutes of the Public Hearing held on December 13, 2021

Proposed Ordinance Levying Taxes for all Berwyn Public Health District Purposes  
For the Tax Year 2021 Collectible in 2022

Secretary's Note: The Berwyn Public Health District conducted the Public Hearing by remote participation due to the Covid-19 pandemic. The Health District is using the Zoom app platform for its meetings. The Health District posted directions for public participation in the Notice of Meeting at the Health District Building, on its website, and in the published Notice of Meeting and Agenda.

1. Secretary Paul called the Public Hearing to order at 3:45 p.m. Attendees on the Zoom app meeting were BPHD officers Avila and Pareda, BPHD Attorney Zdarsky and BPHD Accountant Eagan.
2. Secretary Paul presented the Notice of Meeting and the Lawndale Bilingual Newspaper Certification of Publication as proof that she published the Notice of Public Hearing in the paper on December 2, 2021. A copy of the Notice of Meeting, Agenda and Proof of Publication are attached and made a part of the record.
3. Secretary Paul announced the title of the Ordinance and recognized Mr. Eagan. Mr. Eagan commented on financial aspects in the Ordinance and concluded by stating that the proposed Ordinance asked for a total levy of \$715,151 dollars which was a levy increase equal to 1.9%.
4. Secretary Paul opened the floor for public comment. President Avila thanked everyone for their prior comments and work to draft the proposed Ordinance. There were no other comments.
5. Secretary Paul concluded the Public Hearing. The Public Hearing adjourned at 3:51 p.m.

The Berwyn Township Public Health District Board announces that a **Public Hearing** on a proposed tax levy increase for all Berwyn Health District purposes will be held on December 13, 2021 at 3:45 p.m. Due to Governor Pritzker's Emergency Orders with regard to COVID-19 and because the Health District offices are currently being used for COVID testing and vaccination of Berwyn Residents the Public Hearing will be held remotely using the Zoom Meeting application.

The Tax Levy Ordinance seeks to collect \$715,151 for all Health District purposes for tax year 2021 to be collected in 2022. This is a 1.9% increase over taxes levied the prior tax year.
