HIGHWAY COMMISSIONER – Commissioner Nickels reported patching, picking up garbage, brush, working on equipment, worked 3 days with Greenwood Township one of those days in Hebron Township, replaced culvert on Okeson Rd with the Hebron Drainage District, the railroad crossing is done and the lights should be installed by the end of the month. 50K in salt at \$83.47 a ton.

CEMETERY – 0 staking, 0 grave sales. There was one complaint on a stone being hit and moved, B & B Lawn Care moved it back Oct 22nd. Still waiting on the damage to the Township Building to be fixed.

Would like a timeline on revisiting the cemetery referendum & maybe bring in some ideas on fundraising.
