

TAX LEVY ORDINANCE

ROAD DISTRICT

ORDINANCE NO.---

An ordinance levying taxes for all road purposes for Stookey Road District, St. Clair County, Illinois, for the tax year 2017, collectable in 2018.

BE IT ORDAINED by the Board of Trustees of Stookey Township, St. Clair County, Illinois, as follows:

SECTION 1: That the Highway Commissioner of Stookey Road District on Nov 6th, 2017 does hereby determine and declare that the sum of FOUR HUNDRED EIGHTY THREE THOUSAND THREE HUNDREDTHIRTY FIVE DOLLARS (\$483,335.00) is hereby levied upon all property subject to taxation within the Road District as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Road District as required by statute or voted by the people in accordance with the law, for such purpose as:

SECTION 5: That if any section, subdivision, or sentence of this ordinance shall for any reason be held invalid or to be unconstitutional, such finding shall not affect the validity of the remaining portion of this ordinance.

SECTION 6: That this ordinance shall be in full force and effect after its adoption, as provided by law.
