**BUDGET & APPROPRIATION ORDINANCE**

**TOWNSHIP**

**ORDINANCE No. 6152022**

An ordinance appropriating for all town purposes for Chemung  
 Township, McHenry County, Illinois, for the fiscal year beginning  
April 1, 2022 and ending March 31, 2023.

BE IT ORDAINED by the Board of Trustees of Chemung Township,  
McHenry County, Illinois.

SECTION 1: That the amounts hereinafter set forth, or so much thereof as may be authorized by law, and as may be needed or deemed necessary to defray all expenses and liabilities of Chemung Township, be and the same are hereby appropriated for the town purposes of Chemung Township, McHenry County, Illinois, as hereinafter specified for the fiscal year beginning April 1, 2022 and ending March 31, 2023.

SECTION 2: That the following budget containing an estimate of revenues and expenditures is hereby adopted for the following funds,

SECTION 3: That the amount appropriated for town purposes for the fiscal year beginning

April 1, 2022 and ending March 31, 2023 by fund shall be as

**TOTAL APPROPRIATIONS:** \$266,438

SECTION 4: That if any section, subdivision, or sentence of this ordinance shall for any reason be held invalid or to be unconstitutional, such decision shall not affect the validity of the remaining portion of this ordinance.

SECTION 5: That each appropriated fund total shall be divided among the several objects and purposes specified, and in the particular amounts stated for each fund respectively in Section 2, constituting the total appropriations in the amount of Two hundred sixty six thousand four hundred thirty eight and no/100----- Dollars (\$ 266,438.00 ) for the fiscal year beginning April 1, 2022 and ending March 31, 2023.

SECTION 6: That Section 3 shall be and is a summary of the annual Appropriation Ordinance of this Township, passed by the Board of Trustees as required by law and shall be in full force and effect from and after this date.

SECTION 7: That a certified copy of the Budget & Appropriation Ordinance shall be filed with the County Clerk within 30 days after adoption.
