Three-Point Contact

OWNSHIP OFFICIALS are providing their communities more and more services each year. Unfortunately, some of these services can be hazardous, sometimes unexpectedly. Accidents can happen in an office setting, let alone while being out on the roads, and operating vehicles and equipment.

TOIRMA provides its members workers' compensation coverage to help protect townships with these work-related injury events. Workers' compensation claims for the 2017-2018 TOIR-MA Program year accounted for 47% of total claims incurred.

During a recent claims review meeting

it became clear that there was a trend in several of our workers' compensation claims. The injuries could have been prevented, for they occurred when individuals were either getting on or off a vehicle or equipment incorrectly. For example, one employee was dismounting a backhoe without using a hand to contact the equipment. He slipped and lost his footing, grabbed the railing, and tore his shoulder. Not only was this extremely painful, but the employee missed a significant amount of work, and had to have surgery.

Maintaining three points of contact while getting on and off vehicles and equipment will aid in the prevention of injuries. Workers should face the vehicle or equipment when dismounting and mounting and keep either both hands and one foot, or two feet and one hand in contact with the vehicle or equipment. Utilizing three-point contact is an important safety practice that helps maintain a person's center of gravity and helps ensure that they are less likely to lose their balance.

TOIRMA has a new "Three-Point Contact" sticker available for our members to use. The sticker serves as a reminder to persons the importance of safety, and the three-point rule. The sticker is designed to fit on the steps of trucks and equipment.

Mounting & Dismounting Equipment

Mounting and dismounting equipment causes many injuries each year. Some injuries are as serious as broken ankles or knees.

3 Point Contact (the Safety Triangle) provides safety for mounting and dismounting equipment, even with hazardous conditions such as mud, snow, or ice.

When you get on or leave the machine, always:

- Maintain a three point contact with the steps and hand holds.
- Face the machine when either mounting or dismounting.
- Never jump on or off the machine. Never attempt to mount or dismount a moving machine.
- Do not use the steering wheel or any control lever as a hand hold when you enter or leave the machine.
